ORDINANCE NO. 10-11

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY,  
PENNSYLVANIA AMENDING ORDINANCE NO. 96-3 RELATING TO CHARGES AND  
DISCOUNTS FOR GARBAGE COLLECTION SERVICES WITHIN THE CITY OF  
JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA

This Amendment increases rates for garbage collection services within the City. If adopted, the collection rates for residential customers will increase to \$13.50 per month.

The collection rates for commercial accounts will increase and be set as follows:

RATES FOR COMMERCIAL ACCOUNTS

<u>Quantity</u>	<u>Monthly Rate</u>
Minimum = less than five (5) bags per pickup	\$14.00
10-14 bag per pickup	\$20.00
15-19 bags per pickup	\$38.00
20-24 bags per pickup	\$50.00
25 and over bags per pickup	\$62.00

RATES FOR ACCOUNTS UTILIZING DUMPSTERS

2 yard dumpster	\$20.00 per pull
3 yard dumpster	\$25.00 per pull
6 yard dumpster	\$34.00 per pull
8 yard dumpster	\$44.00 per pull

Any account which requires the temporary use of a dumpster may lease same from the City for a period not to exceed seven (7) days, at the following rates: a rate increase as follows:

3 yard dumpster.....\$150.00 per pull

6 yard dumpster.....\$175.00 per pull

If adopted, permit fees for oversized dumpsters will increase to \$55.00 per year, payable to the City Treasurer at the time the permit is issued. Applications for oversized dumpsters must be through the City Clerk. This permit will be renewable on an annual basis upon successful completion of an inspection of the dumpster by the City Foreman.


If adopted, the permit fee for temporary use of oversized dumpsters will increase to \$55.00 per week, payable to the City Treasurer at the time the permit is issued. Applications for temporary use of dumpsters must be through the City Clerk and must be acquired and paid for before dumpster is in place.

If adopted, the Senior Citizen's Discount procedure and practice will be amended as follows:

- a. If a citizen is 65 years of age or older and lives alone, then that person is entitled to a discount of 30% of the service fee imposed herein.
- b. If two (2) citizens reside together and both are 65 or older, then they shall be entitled to a discount of 30% of the service fee imposed herein.
- c. In order to qualify for a senior citizen discount for the following year, the person or persons seeking the discount must apply for same at the office of the City Clerk, and as part of the application process, provide proof of age for the most recent year. Such application and proof of age must be provided on or before the 30<sup>th</sup> day of November of the year preceding the one in which the discount is requested for the discount in the following year to apply.
- d. The City Clerk shall provide the City Treasurer a list of all persons qualifying for a discount under this section on an annual basis."
- e. The "Senior Citizen Discount" shall be available for "owner occupied" property only. It shall not be available for rental properties or other properties in which the owner is not a full time resident.


