ORDINANCE NO. 17-01

**AN ORDINANCE OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA AMENDING ORDINANCE NO. 99-05 AUTHORIZING INCREASED THIRD PARTY BILLING AND SERVICE CHARGES FOR EMERGENCY SERVICES AND EQUIPMENT.**

**WHEREAS**, the City of Jeannette Police and Fire Departments provides timely and efficient emergency services; and

**WHEREAS**, certain of those services provided may be, from time to time, subject to reimbursement through homeowner's or other insurance policies coverage; and

**WHEREAS**, the City desires to implement a fair and equitable procedure by which to recover costs associated with public safety services rendered to and shall establish a process to recover the costs for providing said services; and

**WHEREAS**, costs have increased and should more accurately reflect the updated proprietary cost schedule for emergency services incidents.

**NOW THEREFORE, BE IT HEREBY ORDAINED AND ENACTED** by the Council of the City of Jeannette that:

1. That the City of Jeannette Police and Fire Departments are hereby authorized to bill insurance carriers for services rendered to third parties in emergency situations whenever such services may be covered by liability or hazard insurance.
2. The recovery costs shall be enacted as set forth in Exhibit "A," attached hereto and incorporated herein by reference, and shall be effective upon passage.
3. The costs imposed for the services shall be those which are usual, customary and reasonable costs, which shall include costs for any service, personnel, supplies, equipment and management.
4. The costs shall vary based on the actual cost of the individual events and public safety services so rendered.
5. The billing for such services shall be coordinated through the Chief of Police, City Clerk and Fire Chief of the City of Jeannette.
6. All monies received in reimbursement for such services shall become part of the City's general fund.
7. The Council of the City of Jeannette may amend the Schedule of Fees from time to time by resolution.
8. This Ordinance repeals any ordinance or part thereof that is inconsistent herewith and
