Mr. Clark: The Recreation Department is hiring a maintenance person and a Recreation Director.

Thanked Lou Altieri and the Horn Family for doing the Easter Egg Hunt – Nice Weather.

Mr. Smith: Fire Dept. – Joe Matijevic had 197 Incidents; 2 Fires – 29 inspections – Talked about the Ordinance. Rich Ault gave report on Sanitation – 229.29 tons in March – 12 Tons per day.

Mr. Levander: Five Catch Basin Repairs; Clean-up is three Saturdays in June – commented on the one large item pick up.

Mr. Jacobelli: Spoke about the Comprehensive Plan – Open discussions April through September 30 – Police Chief Binda said he had 466 incidents, 15 arrests, 1,199 calls for service; Gun Locks – can be given out three person limit.
