ORDINANCE NO. 81 - 2

AN ORDINANCE ESTABLISHING THE COMPENSATION TO BE PAID THE OFFICERS AND EMPLOYEES OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, FOR THE YEAR 1981.

BE IT ORDAINED AND ENACTED by the Council of the City of Jeannette, and it is hereby ordained and enacted, as follows:

SECTION 1 That the members of the Police Department of the City of Jeannette shall receive the following compensation for the year 1981.

- (a) Chief of Police - \$24,686.84 per annum base pay.
- (b) Captain of Police - \$23,142.79 per annum base pay.
- (c) Lieutenants, Sergeants, and Patrolmen - as per Agreement dated December, 1979.

SECTION 11 That the members of the Fire Department of the City of Jeannette shall receive the following compensation for the year 1981.

- (a) Fire Chief - \$21,243.22 per annum base pay.
- (b) Fire Captain and Shift Heads - as per Agreement dated September, 1979.
- (c) Call Firemen (when filling in for a regular) - \$~~3.50~~ per hour.

SECTION 111 That Metermaids shall be paid for the year 1981:

- (a) Metermaid - \$3.81 an hour.
- (b) Metermaid - \$3.38 an hour.

SECTION 1V That call firemen shall be paid for the year 1981 at the rate of \$3.50 per hour.

SECTION V That the City Clerk shall receive the salary for the year 1981 in the amount of \$22,098.66 per annum.

SECTION VI That the City Engineer shall receive a salary for the year 1981 in the amount of \$5,084.85 per annum.

SECTION VI1 That the City Solicitor shall receive a salary for the year 1981 in the amount of \$9,702.09 per annum.

SECTION VI11 That the personnel of the Community Development Department shall receive salaries for the year 1981 as follows:

- (a) Coordinator - \$18,312.00 per annum.
- (b) Housing Inspector A - \$12,208.00 per annum.
- (c) Housing Inspector B - \$11,720.00 per annum.
- (d) Secretary - \$8,300.00 per annum.

SECTION IX That the City Tax Collector shall receive a salary for the year 1981 in the amount of \$1,800.00 per annum.

SECTION X That the personnel of the City Treasurer's Office shall receive salaries for the year 1981 as follows:

Position A - \$2,966.67 per annum.

Position B - \$2,766.67 per annum

Position C - \$2,666.67 per annum

SECTION XI City office personnel shall receive salaries for the year 1981 as follows:

Position A - \$8,900.00 per annum.

Position B - \$8,300.00 per annum.

Position C - \$4.40 per hour.

SECTION XII That the members of the Street Department, Sanitation Department, and Sewage Department, shall receive wages for the year 1981 as per the Collective Bargaining Agreement between the City of Jeannette and the Teamsters, Chauffeurs, Warehousemen and Helpers Local No. 30 made in December, 1979.

SECTION XIII That the Ordinance Officer shall receive a salary for the year 1981 in the amount of \$12,500.00 per annum.

SECTION XIV That the Street and Sanitation Foreman shall receive a salary for the year 1981 in the amount of \$16,633.40 per annum.


SECTION XV That the personnel of the Sewage Department shall receive salaries for the year 1981 as follows:

(a) Engineer - \$22,930.00 per annum.

(b) Secretary/Clerk - \$8,900.00 per annum.

(c) Assistant - \$8,300.00 per annum.
