ORDINANCE NO. 81 - 15

AN ORDINANCE OF THE CITY OF JEANNETTE ELECTING TO BECOME SUBJECT TO THE PROVISIONS OF THE GENERAL COUNTY ASSESSMENT LAW; ACCEPTING THE ASSESSMENT OF PROPERTY IN SUCH CITY FOR CITY PURPOSE; ELECTING TO ACCEPT THE ASSESSMENT AS ADOPTED BY THE COUNTY OF WESTMORELAND OF 100% OF MARKET VALUE TO ASSESSED VALUE AND REPEALING ALL ORDINANCES INCONSISTENT HEREWITH.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the City of Jeannette, at a regular meeting thereof, held on the 30th day of Dec., 1981 that:

WHEREAS, the County of Westmoreland is a third class county, organized and existing under the laws of the Commonwealth of Pennsylvania and subject to the provisions of the General County Assessment Law, 1933, May 22, P.L. 853, Art. 1, (101 et. seq., and,

WHEREAS, The City of Jeannette is a third class city organized and existing under the laws of the Commonwealth of Pennsylvania, and

WHEREAS, The City desires to elect to become subject to the provisions of the General County Assessment Law, and

WHEREAS, THE City desires to accept the assessments of property within the City by the County, and

WHEREAS, The City desires to accept the rates of 100% of market valuation for assessed valuation as adopted by the County.

NOW, THEREFORE, inconsideration of the above, Council adopts the following.

SECTION 1. The City of Jeannette elects to become subject to the provisions of the General County Assessment Law pursuant to authority granted by 72 P.S. (5350; 1931, June 26, P.L. 1379, (19; 1967, November 24, P.L. 520, (1.


SECTION 11. The City of Jeannette accepts the assessment of property by the County in said city for city purposes.

SECTION 111. The City of Jeannette accepts the rates of 100% market valuation to assessed valuation as determined by the County of Westmoreland, pursuant to the provisions of the General County Assessment Law.

SECTION 1V. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.


SECTION V. This ordinance shall take effect on January 1, 1982.
