ORDINANCE NO. 81-16

AN ORDINANCE OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, AND THE COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR 1982 AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HEREAFTER SET FORTH, DURING THE CURRENT YEAR.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Council of the City of Jeannette, Westmoreland County of Pennsylvania.

SECTION 1. That taxes be and the same are hereby levied on real property, persons and income within the municipality for the fiscal year 1982 as follows:

- Real Estate - for each dollar of assessed valuation
 - Recreation - .19 mills
 - Library - .19 mills
 - General Purposes - 14.15 mills
 - Debt Service/Unfunded Debt Loan - 1.42 mills
 - Wage and Income Tax: - .50 mills
 - Residence Tax - \$5.00 on all persons over the age of 21 with the exception of persons over the age of 65 who make application to the City Treasurer for exemption:
 - Occupation Privilege Tax - \$10.00 on all persons working within the municipality who earn more than \$1,000.00
 - Business Privilege tax - $\frac{1}{2}$ mill on gross receipts of wholesale vendors, and $\frac{2}{3}$ mill on gross annual receipts of all others, retail and service.
- Real Estate transfer tax of $\frac{1}{2}$ of 1% of consideration or value.

SECTION 11. That for the expenses for the fiscal year 1982 and following amounts are hereby specifically appropriated from the revenues available for the specific purposes set forth below, which amounts are more fully itemized in the Budget Form.

SECTION 111. That the total estimated receipts, including the revenues from the above levied taxes and from all other sources, for the fiscal year 1982, which amount is more fully itemized in the Budget Form, is \$2,407,482.

SECTION 1V. That all ordinances or parts of ordinances inconsistent herewith are hereby repealed.
