ORDINANCE NO. 82-5

BILL NO. 82-3

AN ORDINANCE AMENDING CERTAIN SECTIONS OF ORDINANCE NO. 56-1 ENTITLED "AN ORDINANCE TO PROVIDE FOR THE COLLECTION, REMOVAL OF GARBAGE, SEWAGE..., REPEALING ALL PARTS INCONSISTENT HEREWITH.

BE IT ORDAINED AND ENACTED and it is hereby ordained and enacted by the Council of the City of Jeannette, at a regular meeting thereof, held on the 23RD day of MARCH, 1982, that

WHEREAS, pursuant to 53 P.S. (37403 (6) Council has been granted specific power to provide for and regulate the collection, removal and disposal of garbage, ashes and other wastes or refuse material, and;

WHEREAS, Council desires to amend its ordinance to regulate the collection removal and disposal of garbage.

NOW, THEREFORE, in consideration of the above, Council adopts the following:

SECTION 1.

The Family Unit Rate imposed by Ordinance No. 80-17 is hereby continued. However, the amount of garbage shall be limited to five (5) thirty-two (32) gallon containers per week for each Family Unit or Domestic Account. Whenever the total amount of garbage or refuse exceeds five (5) thirty-two (32) gallon containers, the head of the household shall be assessed an additional charge of 25¢ per container in excess of the limit imposed herein.

SECTION 11.

All structures occupied by more than (2) families shall be required to dispose of their garbage, refuse or rubbish in metal containers, not to exceed thirty-two (32) gallons in size.

SECTION 111.

Anyone disposing of an appliance or other article of personal property specifically described in the attached Schedule "A" made a part hereof, shall be assessed the fee as set forth therein. Further, arrangements must be made in advance by paying the fee and obtaining a sticker to be attached to the appliance. Said sticker shall be available at the office of the City Clerk during normal business hours.

SECTION IV. SENIOR CITIZEN DISCOUNT

- A. If a Citizen is 65 years of age or older, lives alone, and has gross annual receipts from all sources, including pensions, social security, rents or dividends, less than ~~\$7,500.00~~ ^{\$8,000.00 PFT} per year, then that person is entitled to a discount of 30% of the service fee imposed herein.
- B. If two (2) citizens reside together and one is 65 or older, and they are both unemployed, and their gross annual receipts from all sources, including pensions, social security, rents, dividends or other sources, is less than ~~\$10,000.00~~ ^{\$12,000.00 PFT} then they shall be entitled to a discount of 20% of the service fee.

SECTION V.

There is hereby imposed a ten percent (10%) penalty on the principal amount if not paid within the billing period and a charge of $\frac{1}{2}\%$ per month interest on any outstanding balance.


SECTION VI.

This ordinance to take effect immediately upon final passage.


