AN ORDINANCE OF THE CITY OF JEANNETTE VACATING A CERTAIN
UNNAMED 15' ALLEY SITUATE BETWEEN NORTH SECOND STREET
AND AN UNNAMED ALLEY RUNNING PARALLEL TO NORTH SECOND STREET.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the
Council of the City of Jeannette, at a regular meeting thereof held on the
25TH day of NOVEMBER, 1987, that

WHEREAS, the City has received a petition from all of the property owners,
in number and interest, to vacate a certain unnamed 15' alley situate between
North Second Street and an unnamed alley, and;

WHEREAS, the City has the authority to vacate an alley or street upon its
own motion or upon receipt of a petition;

WHEREAS, The City Engineer, City Solicitor, Police Chief and Fire Chief
have reviewed the petition.

NOW, THEREFORE, in consideration of the above and intending to be
legally bound hereby, Council adopts the following:

- 1) The certain unnamed 15' alley situate between North
Second Street and an unnamed alley, as more specifically
described in exhibit A attached, be and is hereby vacated.
- 2) The vacated alley shall revert to and become the property of
the adjoining property owners to the centerline.
- 3) This ordinance shall take effect immediately, provided the
City shall retain and except any easements or right of way
existing in the aforesaid.
