ORDINANCE NO. 90-11

AN ORDINANCE OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR 19 91AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HEREINAFTER SET FORTH, DURING THE CURRENT YEAR.

BE IT ORDAINED AND ENACTED, and it is hereby Ordained and enacted by the Council of the City of Jeannette, Westmoreland County, Pennsylvania:

SECTION 1. That taxes be and the same as hereby levied on real property and income within the municipality for the fiscal year 19 91as follows:

- Real Estate - for each dollar of assessed valuation.
- General Purposes 18.48 mills
- Debt Service/Unfunded Debt Loan 2.10 mills
- Recreation .21 mills
- Library .21 mills
- Total 21.00 mills
- Earned Income Tax 5 mills
- Residence Tax - \$5.00 on all persons over the age of 21 with the exception of persons over the age of 65 who make application to the City Treasurer for exemption.
- Occupation Privilege Tax - \$10.00 on all persons working within the municipality who earn more than \$1,000.00
- Business Privilege Tax - 1/2 mill on gross receipts of wholesale vendors, and 2/3 mill on gross annual receipts of all others, retail and service. Real Estate transfer tax of 1/2 of 1% of consideration or value.

SECTION 11. That for the expense for the fiscal year 19⁹¹ and following amounts are hereby specifically appropriated from the revenues availablefor the specific purposes set forth below, which amounts are more fully itemized in the Budget Form:

Department of Public Affairs	\$ 825,243.00
Department of Accounts & Finance	\$ 224,591.00
Department of Accounts & Finance Misc.	\$1,088,679.00
Department of Public Safety	\$ 854,796.00
Department of Streets & Improvements	\$ 410,351.00
Department of Parks & Public Buildings	\$ 106,400.00
Total Estimated Expenditures	<u>\$3,510,060.00</u>

SECTION 111. That the total estimated receipts, including the revenues from the above levied taxes and from all other sources, for the fiscal year 1991, which amount is more fully itemized in the Budget Form, is \$ 3,481,122.00 .


SECTION 1V. That all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
