**AN ORDINANCE OF THE CITY OF JEANNETTE
PROVIDING FOR ONE WAY TRAFFIC ALONG
EAST DIVISION STREET IN THE
CITY OF JEANNETTE.**

WHEREAS, the Council of the City of Jeannette has determined that the flow of traffic from East Division Street onto Lewis Avenue, due to the nature of the intersection between such roadways, could result in danger or damages to persons or property; and

WHEREAS, the Council of the City of Jeannette desires to regulate the direction of traffic along East Division Street to prevent its movement eastward onto Lewis Avenue; and

WHEREAS, the Engineer of the City of Jeannette and the Chief of Police of the City of Jeannette have recommended that East Division Street be restricted to one way traffic flowing West from Lewis Avenue toward Lowry Avenue; and

WHEREAS, the Council of the City of Jeannette believes that such restriction is necessary to ensure safe passage upon and over East Division Street.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE DOES HEREBY ORDAIN AND ENACT THE FOLLOWING:

1. That travel upon East Division Street shall be limited to "One Way", with the flow of traffic restricted to a westerly direction of travel.

2. The portion of East Division Street subject to such restriction shall be from its intersection at Lewis Avenue to its intersection with an unnamed alleyway running parallel to Lowry Avenue, such alleyway being approximately 185 feet from the intersection of East Division Street with Lowry Avenue.

3. The Chief of Police, City Engineer and City Foreman are hereby directed to post appropriate signs at the intersection of East Division Street and Lewis Avenue as well as East Division Street and the aforesaid unnamed alley to indicate that travel upon such roadway is restricted to one way and that there shall be no entry upon East Division Street going eastbound from the point of the aforesaid alleyway West.

4. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.


THIS ORDINANCE IS DULY ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF JEANNETTE AT A PUBLIC MEETING HELD THE 9th DAY OF DECEMBER, 1998 AND SHALL TAKE EFFECT IMMEDIATELY.
