CITIZENS:

Retirement of K-9 Arees: Chief of Police Donald Johnston presented K-9 Officer Arees and his handler, Sgt. James Phillips with a plaque to honor his 7 years of service in the City of Jeannette and in the surrounding communities.

Robert McLoughlin: A Penn Township resident and former resident of Jeannette for 61 years, made a request regarding item number 12 on the agenda to change the time of the scheduled meeting to 6:00 PM to be more inclusive

of the residents in the City. He mentioned that he personally invited businesses and, with the assistance of Councilwoman Mozley and Councilwoman Langdon, to organize the Jeannette Business Forum, in which more people attended said meeting than were present during this Council Meeting. Mr. McLoughlin acknowledged the plights of his patients, who live in the City, in which it is perceived that a 1:00 PM meeting is less inclusive than that of a meeting scheduled at 6:00 PM due to the cost of missing work to attend the meeting. He acknowledged the inconvenience of the City workers and representatives to return to City Hall in the evening but also indicated that the inconvenience to interested residents is greater.

Dan Orange: Lives on Ash Street in Jeannette and is a long-time member of the Jeannette Community Band (JCB). Mr. Orange briefly described the JCB and its history, as well as the donations required to maintain operations. Mr. Orange stated that the fee for use of the Elliott Group Amphitheater is too great for the JCB, being a nonprofit organization, to pay. He requested that Council reconsider the fee to encourage more events meant to draw people into the City.

Sherrie Wood: As the Secretary of the JCB, she stated that the JCB was the dedication band for the Elliott Group Amphitheater and that she was the speaker during the event. She stated that the band was proud to be part of this event and looked forward to performing many concerts at the Amphitheater. Being a 501(c)(3) organization surviving on donations, the JCB cannot afford to pay the \$500.00 fee, in which the band has not paid for performances in 34 years of operation. Concerts performed at the Amphitheater would not require street closures or a police presence, and the performance would likely bring families willing to go to the surrounding restaurants following these events. She requested that the fee for use of the Amphitheater be waived for nonprofit organizations.

Joann Billheimer: A Jeannette resident on Cedar Street addressed Council on the Amphitheater fee for nonprofit organizations, such as the Westmoreland County Band, who also relies on donations to continue operations.

Joe Scarlic: A Monroeville resident whose parents lived in the City for many years and whose brothers and sister currently reside in the City, addressed Council regarding the Amphitheater fee for nonprofit organizations, such as the Jeannette Community Band.

Rob Turner: Vice President of Adamsburg Council wants to learn more about the meeting procedures and operations and possibly collaborate between Councils for mutual benefit.

Linda Washington: A Jeannette resident for 43 years, addressed Council on behalf of the owners of AB Ceramics, Eric and Tom Slack, who could attend the meeting by reading a letter written by the owners. The letter requests that parking be made available on both sides of South 4th Street in order to provide more parking spaces for the business and surrounding businesses in the area.

Kathy Tanyer: A Jeannette resident living on Laura Street, addressed Council on item 10 for the curb pickup event, and indicated that she had requested a Spring and Fall cleanup. Ms. Tanyer acknowledged the large items as a

problem and that she feels that cleanups are necessary to remove this waste from the City. She noted that item 11 will not be serviceable, as few people will be willing to take large items to a central location, such as a strategically placed dumpster. Many residents do their part to keep the City clean without assistance from the City, and that the residents require City assistance now to clean the City and its gateways. Ms. Tanyer requested to have large item pickup twice despite overtime accumulation, as the Public Works employees will likely enjoy the overtime hours as "one of the most overlooked departments." She stated that the wear and tear on the sanitation vehicles is a non-issue, as the wear and tear will occur regardless of the extra cleanup events. Ms. Tanyer further addressed Council on the Amphitheater fee, requesting that Council reduce the fee for nonprofit organizations. She indicated that the amphitheater construction was paid for with tax credit money through the Neighborhood Partnership Program's (NPP) efforts. She believed that a \$500.00 fee is exclusionary to organizations throughout the City and that the fee should be revisited to become more reasonable.
