Understands that the CFO is looking for grants but who is going to pay for the damages if the wall collapses? Just wants to keep what he has.

Chris Miller: 731 Sellers Ave, sellers avenue is a nice avenue except for three houses that are right next to each other. The people on the street try to keep their properties nice but these three properties are eye sores. One of the houses is a dumpsite for garbage and furniture. It's a fire hazard with red Xs spray painted on them by the fire department. These houses are bringing down the property values for the whole street. Kids try to get in them all the time, some could get hurt badly. Houses are full of raccoons that come out through the roofs of one of the buildings. Raccoons carry rabies kids may get bitten and hurt. How would you like it if this was on your street.?

Lauran Wagner: Fully behind what Chris Miller was stating. These houses on Sellers Ave need demoed so the property values on the rest of the street go up. These houses make them feel unsafe in their own homes. There are ticks everywhere and it is harming the animals. Rats and raccoons are ripping up the garbage bags in the area so we have to clean it and spend more money rebagging the garbage. Something needs done.
