Eighteen (18) accounts reconciled and only four (4) more to reconcile to be caught up.

**Mrs. Langdon** – Nothing to report. She thanked Ron Smith for his service as being an asset to the City. He will be dearly missed.

**Mrs. Mozley** – No report for Sanitation. Three (3) dumpsters delivered to the Magee Parking Lot for the Trash Cleanup Week with a total of twelve (12) pulls for the week, and she foresaw performing more cleanup weeks in the future. Chief Bill Frye gave the Fire Department Monthly Report and addressed the Manor issue. A Knox Box has been ordered to be installed at the Jeannette Public Library. Management at the Manor has been responsive, but the agreement for inspections with the City has not been finalized. The project is a good thing for fire safety. Bill Whetzel read the Property Maintenance Report for the Month and also gave the Code Enforcement Monthly Report. Mrs. Mozley indicated item number 12 for Public Works Supplemental Help.

**Mr. Antoniak** – Chief Johnston attended a memorial service on behalf of International Police Week honoring fallen officers, and he listed the fallen officers from the City.
