Council could have gotten JBA feedback regarding the fee and its eventual cost but didn't. Also is upset regarding the \$500 fee for use of the Amphitheater. Michelle Langdon: Is a small business owner and member of the JBA. There was a mix-up with the garbage pick up this week. Robin Mozley took responsibility and provided a solution to the issue and that is what is needed from our Council. Mr. Ault interjected and took responsibility for the mistake as did Mr. Bish. The business privilege tax has been on the books for a very long time but there was no law to enforce the collection of the take. "Turnkey" taxes were brought in either in 2015 or 2016 to collect the business privilege tax and delinquent taxes. This organization provided a "narrative" to Council regarding the issues in collecting the tax but lost patience so they terminated the agreement. Last year the city adopted an ordinance that had the required provisions that "turnkey" was suggesting, to aid in the collection of the tax. With all that being said, the creation of a business registration fee that is too high is not the answer to the city's issues. Suggests raising the business privilege tax to be more equitable for the businesses of Jeannette.

Sharon Bush: Inquired if the communications will be read at the meeting. Mr. Bish interjected and explained that copies of the communications are available for all to read but would not read the letters word for word due to the amount of time that would take. The reason for the inquiry was in regards to the letter from Janis Mangan is from the sacred heart rosary society asking for use of the amphitheater for a rosary rally for October 16th. Is supportive of the request and hopes Council approves it.

Kathy Tanyer: In conjunction with Forward Cities, they surveyed the businesses in Jeannette 45 percent of Jeannette businesses are sole proprietorships who do not make more than \$30,000.00 annually. \$50 may not mean a lot to some people but it does to the businesses. New assessments indicate that the City of Jeannette has a 22% poverty rate which is much higher than the state poverty rate of 12%. That would suggest about 2,000 people live in poverty in Jeannette. Please keep these constituents in mind when you vote for new fees. Sometimes transparency is lacking from the city and it is disappointing when it happens. Spoke with Mr. Bish weeks ago regarding communications as it seemed like decisions were being made at the work sessions, specifically the decision regarding Legion's request to close the alleyway. Council is accountable to the voters, please remember that.
