ORDINANCE NO. 18-12

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 2012-03, KNOWN AS THE CITY OF JEANNETTE STORMWATER MANAGEMENT ORDINANCE; AUTHORIZING THE ENFORCEMENT OF SUCH ORDINANCE; REPEALING ALL INCONSISTENT ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Jeannette has determined that the public interest will be best served by enabling the City to use additional persons and entities to enforce its stormwater management ordinance; and

WHEREAS, the Third Class City Code, 53 P.S. 37403(60), affords the City of Jeannette with the power “to make and adopt all such ordinances, by-laws, rules and regulations, not inconsistent with or restrained by the Constitution and laws of this Commonwealth, as may be expedient or necessary for the proper management, care and control of the city and its finances, and the maintenance of the peace, good government, safety and welfare of the city, and its trade, commerce and manufactures.”

**BE IT ENACTED AND ORDAINED** by the City Council of the City of Jeannette, Fayette County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained as follows:

**Section 1.** Part VIII – Enforcement and Penalties. Part VIII, Section 802 shall be amended to insert a new subsection (D), which shall read as follows:

D. This Ordinance, or any part or portion thereof so designated by ordinance or resolution of the Municipality, may be enforced by any entity or person duly authorized by ordinance or resolution of the Municipality to enforce this Ordinance, including, without limitation, the performance of inspections, the issuance of notices of violation, and the issuance of citations.

**Section 2.** Severability. It is herein declared that the provisions of this Ordinance are severable, and if any provisions, portions, or sections of this Ordinance are declared to be illegal, invalid, or unconstitutional, the decisions of any Court, which makes declarations, shall not impair or affect any of the remaining portions of this Ordinance.

**Section 3.** Repealer. Any ordinance or part of any ordinance that conflicts with the provisions of this ordinance is hereby repealed to the extent of any such conflict on the effective date of this ordinance.

**Section 5. Effective Date.** This Ordinance shall become effective immediately after its enactment.

This Ordinance is duly ORDAINED AND ENACTED by a majority of the members of the City Council of the City of Jeannette at a duly advertised public meeting held on the 22nd day of MAY, 2018.
