ORDINANCE NO. 18-19

AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING ORDINANCE NO. 98-11, AS AMENDED, TO REMOVE PORTIONS OF CERTAIN STREETS AS PERMIT PARKING; TO ADD PORTIONS OF CERTAIN STREETS AS PERMIT PARKING; AND MAKE A PORTION OF LEWIS AVENUE AS NO PARKING; REPEALING ALL INCONSISTENT ORDINANCES; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there exists within the City of Jeannette certain areas where parking of vehicles upon the roadways interferes with emergency and other public or essential services or travel; and

WHEREAS, the City of Jeannette has established no parking areas within the City with Ordinance No. 98-11; and

WHEREAS, a study has been conducted and it has been determined that with respect to portions of Lewis Avenue: (i) the distance between the center of the center line pavement markings and the curb or edge of roadway is less than 19 feet; (ii) at the related intersections, the available corner sight distance for drivers on connecting roads is less than the necessary minimum stopping sight distance value for the driver on any through roadway; and (iii) the conditions of the roadway are dangerous for visibility for parked vehicles and the drivers and passengers of such vehicles; and

WHEREAS, the conditions of certain streets no longer require that such streets continue to remain permit parking; and

WHEREAS, the City of Jeannette has the power to erect official traffic-control devices pursuant to 75 Pa.C.S.A. § 6122, 67 Pa. Code § 212.5, and other statutory and regulatory sections.

BE IT ENACTED AND ORDAINED by the City Council of the City of Jeannette, Fayette County, Commonwealth of Pennsylvania, and it is hereby enacted and ordained as follows:

Section 1. Removal of Portions of Certain Streets as Permit Parking. The City hereby amends Ordinance No. 98-11, Section 1, as amended, to remove the following portions of roadways as permitted parking only:

- a. The Western side of Jefferson Avenue from Spruce Street to Broad Street;
- b. Both sides of Jefferson Avenue from Broad Street to Vine Street;
- c. The North side of Broad Street from Lowry Avenue to Lewis Avenue;
- d. Both sides of Locust Street from Jefferson Avenue to Washington Avenue;

- e. Both sides of Spruce Street from Jefferson Avenue to Michigan Avenue;
- f. Both sides of Vine Street from Westmoreland Avenue to Lewis Avenue;
- g. The West side of Lewis Avenue from Park Street to Vine Street;
- h. Both sides of Lewis Avenue from Vine Street to Broad Street;
- i. The East side of Lewis Avenue from Broad Street to Locust Street;
- j. Both sides of Washington Avenue from Broad Street to Park Street;

- l. Both sides of Michigan Avenue from Vine Street to Broad Street;
- m. The East side of Michigan Avenue from Broad Street to a point being 30 feet South from the intersection of Michigan Avenue and Locust Street;
- n. Both sides of Michigan Avenue from Locust Street to Spruce Street;
- o. Both sides of Westmoreland Avenue from Vine Street to Broad Street;
- p. The South side of Westmoreland Avenue from Broad Street to Pennsylvania Boulevard.

Section 2. Confirmation or Addition of Portions of Certain Streets as Permit Parking. The City hereby amends Ordinance No. 98-11, Section 1, as amended, to confirm or to add the following portions of roadways as permitted parking only:

- a. The West side of Washington Avenue from Park Street to Vine Street;
- b. The East side of Michigan Avenue from Park Street to Vine Street;
- c. The East side of Michigan Avenue from Broad Street to Locust Street.

Section 3. Addition of Portions of Certain Streets as No Parking Zones. The City hereby amends Ordinance No. 98-11, Section 2, to add and make the following portions of roadways each as “No Parking Zone” for which a sign designating the same shall be erected:

- a. The East side of Lewis Avenue from Hickory Street to Chambers Avenue;
- b. The West side of Lewis Avenue from Locust Street to Chambers Avenue.

Section 4. Authorization. The City hereby authorizes all City officials and employees to take any and all actions necessary to effectuate and enforce the addition of said portion of roadways as permit parking only or a “No Parking Zone” and this Ordinance, including, without limitation, the erection of any sign and the painting of any curbing or streetway.

Section 5. Severability. It is herein declared that the provisions of this Ordinance are severable, and if any provisions, portions, or sections of this Ordinance are declared to be illegal, invalid, or unconstitutional, the decisions of any Court, which makes declarations, shall not impair or affect any of the remaining portions of this Ordinance.

Section 6. Repealer. Any ordinance or part of any ordinance that conflicts with the provisions of this ordinance is hereby repealed to the extent of any such conflict on the effective date of this ordinance.

Section 7. Effective Date. This Ordinance shall become effective immediately.

This Ordinance is duly ORDAINED AND ENACTED by a majority of the members of the City Council of the City of Jeannette at a duly advertised public meeting held on the 8th day of November, 2018.

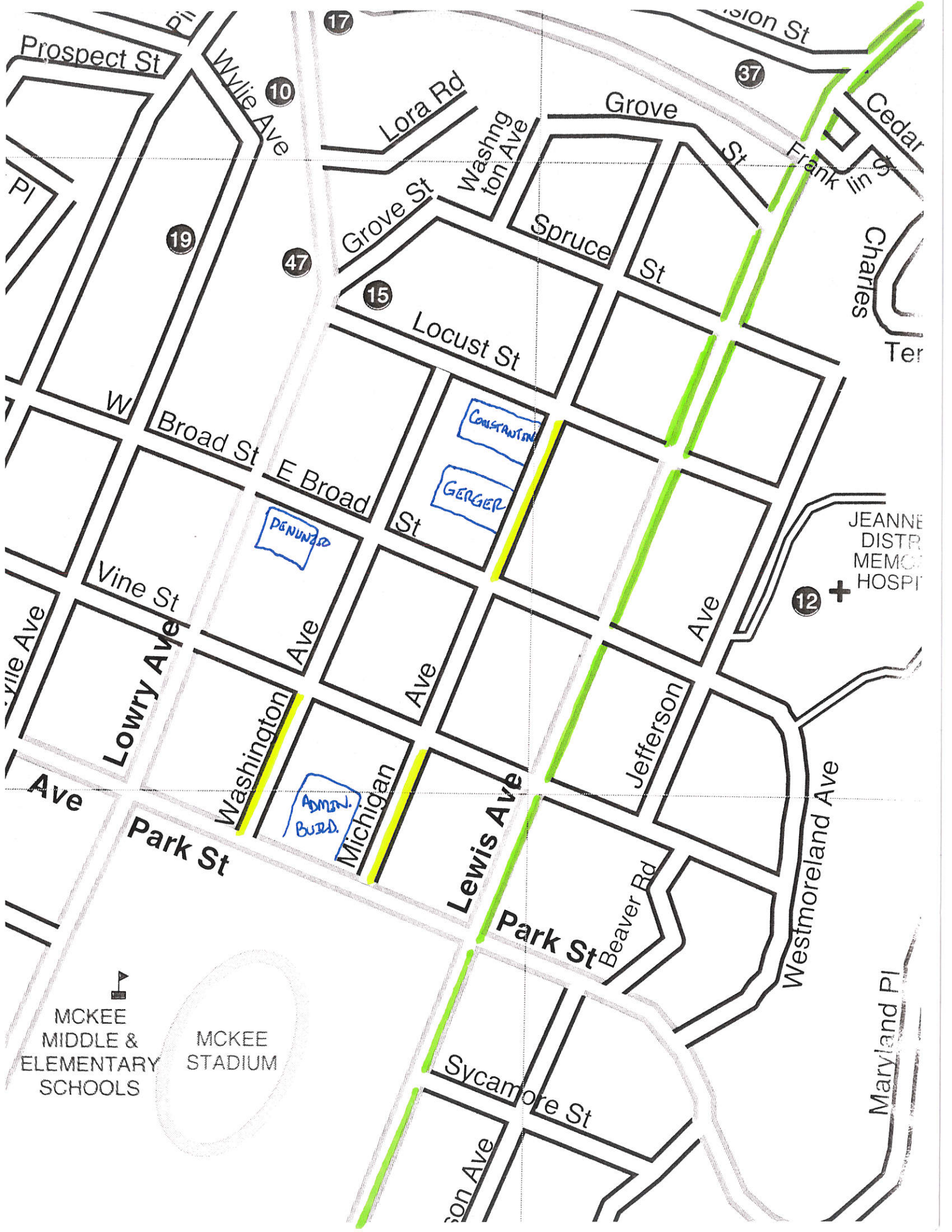
