ORDINANCE NO. 19-11

AN ORDINANCE OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA, FIXING THE TAX RATE FOR 2020 AND APPROPRIATING SPECIFIC SUMS ESTIMATED TO BE REQUIRED FOR THE SPECIFIC PURPOSES OF THE MUNICIPAL GOVERNMENT, HEREINAFTER SET FORTH, DURING THE CURRENT YEAR.

BE IT ORDAINED AND ENACTED, By the Council of the City of Jeannette, Westmoreland County, Pennsylvania, at a meeting held on the 30th day of December, 2019 that:

SECTION I. That taxes be and are hereby levied on real property and income within the Municipality for the fiscal year 2020 as follows:

Real Estate – For each dollar of assessed valuation:

<b>General Purposes</b>	29.23 mills
<b>Debt Services</b>	3.15 mills
<b>Library</b>	1.24 mills
<b>Public Street Light</b>	1.50 mills
<b>Recreation</b>	0.50 mills
<b>Total</b>	<b>35.62 mills</b>

Earned Income Tax:

<b>Resident</b>	1.40 percent
<b>Non-Resident</b>	1.00 percent

- Residence Tax - \$5.00 on all persons over the age of 18 years with the exception of persons over the age of 65 who make application to the City Treasurer for exemption.
- Local Service Tax - \$52.00 on all persons working within the City of Jeannette who earn more than \$12,000.00.
- Business Privilege Tax – 2/3 mill on gross receipts of wholesale vendors, and 3/4 mill on gross annual receipts of all others, retail and service.
- Real Estate transfer tax of 1/2 of 1% of consideration of value.

SECTION II. That for the expense for the fiscal year 2020 the following amounts are hereby specifically appropriated from the revenues available for the specific purposes set forth below, which amounts are more fully itemized in the Budget Form.

Department of Public Affairs	\$1,600,453.42
Department of Accounts and Finances	\$423,764.77
Department of Public Safety	\$2,728,161.20
Department of Streets and Improvements	\$566,338.67
Department of Parks, Public Buildings, Library	\$154,141.95
<b>Total Estimated Expenditures</b>	<b>\$5,472,860.01</b>

SECTION III. The total estimated receipts, including the revenues from the above levied taxes and from all other sources for the fiscal year 2020 which amount is more fully itemized in the Revised Budget Form is \$ 5,472,860.01.

SECTION IV. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
