AN ORDINANCE OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA AMENDING ORDINANCE NO. 96-3, AN ORDINANCE OF THE CITY OF JEANNETTE, FOR THE COLLECTION AND REMOVAL OF MUNICIPAL WASTE AND RECYCLABLES FROM PREMISES WITHIN THE CITY, PROVIDING FOR FEES AND PROCEDURES THEREFORE, DELEGATING RESPONSIBILITY FOR PAYMENT OF PROPERTY OWNERS, IMPOSING FINES AND PENALTIES FOR NON-COMPLIANCE, AND REVOKING ORDINANCE 56-1 AND IT'S AMENDMENTS AND ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT THEREWITH, TO REQUIRE THE DISPLAY OF PERMITS BY PROVIDERS OF DUMPSTERS IN EXCESS OF EIGHT (8) YARDS IN USE IN THE CITY OF JEANNETTE.

WHEREAS, The Council of the City of Jeannette adopted Ordinance No. 96-3 providing for the collection of municipal waste and recyclable materials within the City of Jeannette; and

WHEREAS, Section VI (6) permits the temporary use of dumpsters or containers larger than eight (8) yards through contract with independent solid waste haulers provided application is made by the account/property owner and a permit is issued through the Office of the City Clerk of the City of Jeannette for same; and

WHEREAS, owners of property have contracted with Independent Solid Waste Haulers for the lease of such dumpsters and containers without the benefit of a permit and independent solid waste haulers are providing such dumpsters/containers without determining whether or not the individual account or property owner has applied for and/or received such a permit.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE HEREBY ORDAINS AND ENACTS AS FOLLOWS:

1. Section VI of City of Jeannette ordinance no. 96-3 is hereby amended to add the following paragraph 7:

“7. Any person, corporation, entity or firm acting as an independent solid waste hauler who leases or provides a dumpster/container for the collection and disposal of solid waste pursuant to Section VI, Paragraph 6 of this Ordinance shall prominently display and maintain a copy of the permit issued by the City Clerk pursuant to such Section upon the dumpster or container for which the permit is issued at all times during the use of such dumpster or container. The failure to have such permit prominently displayed upon the dumpster or container at any time during its use shall be deemed a violation of this Ordinance and subject such person, entity, corporation and/or firm to the penalty provisions set forth in Ordinance No. 96-3.

THIS ORDINANCE IS DULY ORDAINED AND ENACTED BY THE COUNCIL OF THE CITY OF JEANNETTE AT A PUBLIC MEETING HELD THE 10th DAY OF September, 2003, AND SHALL TAKE EFFECT IMMEDIATELY.
