RESOLUTION NO. 14-03

A RESOLUTION DIRECTING THE CITY OF JEANNETTE
SOLICITOR TO CREATE AND IMPLEMENT AN ADDENDUM
TO AMEND THE CITY IAFF LOCAL 78 FIREFIGHTER
CONTRACT TO REFLECT CHANGES TO THE PROCEDURE
FOR SCHEDULING OF VACATION DAYS

WHEREAS, the City of Jeannette desires to amend the City's firefighter contract with IAFF Local 78, and,

WHEREAS, the City of Jeannette desires to create and adopt an addendum to the contract containing said amendment, the substance of which shall be as follows:

ARTICLE VI-VACATIONS

Section 8: The Firefighter shall take their allocated vacation time according to seniority and in accordance with the following schedule:

- A. Each Fire Fighter shall select all his or her allotted vacation time for the year prior to March 1st of each calendar year. The vacation schedule for all firefighters shall be posted by March 15th of each calendar year.
- B. If a vacation period becomes available because of retirement, resignation or death of a Fire Fighter, that vacation period must be offered to all employees of the department who have not already taken their full allotment of vacation time, or who would like to change their previously schedule but unused vacation time, on the basis of seniority. In the event of a threat to the health, safety or welfare of the public, the City may rearrange times for vacation.
- C. If a Fire Fighter does not select vacation time by March 1st of the calendar year, then he or she shall be placed on the bottom of the seniority list for the purposes of vacation scheduling. In no event shall vacation time be permitted

unless it has been posted a minimum of 3 weeks prior to the date said vacation is to occur. Once vacation time has been scheduled, posted and approved, said time shall not be revoked except in case of emergency or upon agreement of all Fire Fighters scheduled for that day.


NOW, THEREFORE, BE IT RESOLVED that Council of the City of Jeannette, Westmoreland County, Pennsylvania, has approved and adopted in substance the above for addition to the city IAFF 68 Contract.

BE IT FURTHER RESOLVED that Council of the City of Jeanette hereby directs and instructs the City Solicitor to create an addendum to the City IAFF contract reflecting the substance of this resolution, and hereby authorizes official action on behalf of the city to make any and all signatures and approvals necessary to effectuate said addendum,


BE IT FURTHER RESOLVED that the aforesaid employees shall receive other benefits as are set forth in the applicable policies of the City of Jeannette governing such employees.
