**RESOLUTION OF THE CITY OF JEANNETTE CITY COUNCIL APPROVING
THE BUDGET REVISION AND MODIFICATION TO THE FISCAL YEAR 2013
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM YEAR.**

WHEREAS, the City of Jeannette is a recipient of Community Development Block Grant (CDBG) funds through the Commonwealth of Pennsylvania under the State Act 179; and

WHEREAS, the Pennsylvania Department of Community and Economic Development (PA DCED) has provided a grant to the City of Jeannette under the FY 2013 CDBG Program to address the housing, community and economic development needs in the City; and

WHEREAS, there is a balance of funds remaining in the Street Improvements Line Item under the FY 2013 CDBG Program Year; and

WHEREAS, there is a continuing need to demolish vacant and dilapidated structures identified through the City's Code Enforcement Program and Health Board; and

WHEREAS, the City's Community Development Department has prepared a Budget Revision and Modification to allocate funds for the demolition of vacant and dilapidated structures, and a public hearing was held on the proposed budget modification and revision which provided citizens the opportunity to comment on the proposed budget modification and revision; and

WHEREAS, the proposed budget modification and revision consist of the following:

FY 2013 CDBG PROGRAM

Reallocate the balance of funds in the amount of \$38,885.10 in the Street Improvements Line Item that was budgeted for infrastructure improvements on Clay Avenue from South Second Street to Cuyler Avenue. All of the street reconstruction work has been completed and a balance remains in the line item.

The City of Jeannette proposes to reallocate the balance of \$38,885.10 to a new line item activity, Demolition/Clearance. The City will use these funds to demolish vacant, dilapidated structures that have been identified through its Code Enforcement Program and Health Board as blighted and economically infeasible to rehabilitate.

BE IT FURTHER RESOLVED that the Mayor of the City of Jeannette is designated as the Chief Executive Officer authorized to execute all necessary documents on behalf of the City of Jeannette in regard to the Pennsylvania Community Development Block Grant Program; and furthermore, is authorized and made responsible for performing the overall coordination and administration of the City's FY 2013 Community Development Block Grant Program.
