RESOLUTION OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA AUTHORIZING THE HOUSING CONSORTIUM COOPERATION AGREEMENT WITH THE COUNTY OF WESTMORELAND.

WHEREAS, Title II of the National Affordable Housing Act of 1990 provides for funding under the HOME Investment Partnerships Program; and

WHEREAS, the U.S. Department of Housing and Urban Development has notified the County of Westmoreland of its status as a participating entitlement jurisdiction under the HOME Program; and

WHEREAS, the Consortium provisions of HUD's HOME Regulation provide for the creation of cooperative relationships between Urban Counties and local units of government; and

WHEREAS, the Consortium status, if approved by HUD could provide FY 2018, 2018 and 2020 HOME funding for each party to the Cooperation Agreement; and

WHEREAS, the City of Jeannette wishes to participate in the Westmoreland Housing Consortium in order to expand opportunities for affordable housing.

NOW, THEREFORE, BE IT RESOLVED, BY THE CITY OF JEANNETTE, THAT:

1. The Westmoreland County Housing Consortium Cooperation Agreement is hereby in all respects approved.
2. The Mayor, in his official capacity as chief elected officer of the City of Jeannette is hereby authorized to execute the Cooperation Agreement on the behalf of the City.
3. The City of Jeannette hereby agrees to carry out HOME funded activities in a manner

that encourages equal opportunity and fair housing.

4. The City of Jeannette authorizes the automatic renewal of the cooperation agreement for successive qualification periods.
5. If HUD approves the Consortium request, the City of Jeannette agrees to cooperate in the preparation of the County's Consolidated Plan and Annual Action Plans.
