RESOLUTION OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA APPROVING THE MINORITY AND WOMEN'S BUSINESS ENTERPRISE PLAN, SECTION 3 PLAN, AND THE RESIDENTIAL ANTIDISPLACEMENT AND RELOCATION ASSISTANCE POLICY FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM.

WHEREAS, there is a continuing need in the City of Jeannette for a concentrated program of housing and community development to address the needs of low- and moderate-income households; and

WHEREAS, funds are provided under the Housing and Community Development Act of 1974, as amended, to address the aforesaid housing and community development needs; and

WHEREAS, the Commonwealth of Pennsylvania has elected to accept a Block Grant from the U.S. Department of Housing and Urban Development and has developed a Small Cities Community Development Block Grant Program to address the housing and community development needs in the Commonwealth; and

WHEREAS, the City of Jeannette under PA Act 179 of 1984 receives funds from the Commonwealth of Pennsylvania to address its housing and community development needs, and is requesting funds which have been allocated to the City of Jeannette; and

WHEREAS, the City of Jeannette is aware as a requirement under the Housing and Community Development Act that it must abide by the Federal Regulations governing the use of CDBG funds, including the Minority and Women's Business Enterprise Plan ("MBE/WBE") participation, Section 3 participation, and a Relocation and Antidisplacement Policy.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Jeannette, hereby agrees to abide by the Federal Regulations governing the CDBG Program and approves the following policies and plans in conjunction with the CDBG Program:

1. Minority and Women's Business Enterprise Plan;
2. Section 3 Plan; and
3. Residential Antidisplacement and Relocation Assistance Plan.


