A RESOLUTION OF THE CITY OF JEANNETTE, COUNTY OF WESTMORELAND, COMMONWEALTH OF PENNSYLVANIA APPROVING AND AUTHORIZING THE SUBMISSION OF THE FY 2017 CDBG APPLICATION.

WHEREAS, there is a continuing need in the City of Jeannette for a concentrated program of housing and community development to address the needs of low- and moderate-income households; and

WHEREAS, funds are provided under the Housing and Community Development Act of 1974, as amended, to address the aforesaid housing and community development needs; and

WHEREAS, the Commonwealth of Pennsylvania has elected to accept a Block Grant from the U.S. Department of Housing and Urban Development and has developed a Community Development Block Grant Program to address the housing and community development needs in the Commonwealth; and

WHEREAS, the City of Jeannette desires to address its housing and community development needs, and is requesting funds which have been allocated to the City of Jeannette for FY 2017 under the Pennsylvania Act 179 of 1984.

NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Jeannette, hereby approves the City's Community Development Block Grant Application for FY 2017; and authorizes the filing of said application in the amount of \$272,958 for FY 2017 CDBG funds, together with all the assurances and understandings contained therein, for the participation of the City of Jeannette in the Pennsylvania Community Development Block Grant Program; and
