RESOLUTION NO. 98-1

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JEANNETTE APPROVING THE COMMUNITY DEVELOPMENT PROGRAM APPLICATION FOR FISCAL YEAR 1998 AUTHORIZING ITS SUBMISSION TO THE PENNSYLVANIA DEPARTMENT OF COMMUNITY & ECONOMIC DEVELOPMENT.

**WHEREAS:** under Title 1 of the Housing and Community Development Act of 1974, as amended, the Secretary of Housing and Urban Development is authorized to extend financial assistance to communities for activities which will benefit low and moderate income families, aid in the elimination of prevention of slums or blight or other urgent community development needs; and

**WHEREAS:** the Pennsylvania Department of Community and Economic Development (DCED) has invited the City to submit an application for financial assistance in the amount of \$433,034.00; and

**WHEREAS:** the City of Jeannette has conducted public hearings and has met all citizens participation requirements relative to the Program submission; and

**WHEREAS:** the City of Jeannette has prepared a Three Year Plan and Statement of Objectives as required by DCED; and

**WHEREAS:** an Anti-Displacement and Relocation Plan and Minority Business Plan was previously adopted; and

**WHEREAS:** the City of Jeannette has previously adopted a fair housing resolution; and

**WHEREAS:** the City of Jeannette has prepared an Application for financial assistance under the Community Development Program, said application having been duly reviewed and considered by the City Council of the City of Jeannette.

**NOW, THEREFORE,** be it resolved by the City Council of the City of Jeannette:

- 1) That the Community Development Program Application dated February, 1998, is hereby in all respects approved. The City Clerk is hereby directed to file a copy of said program and application with the minutes of this meeting.

- 2) That it is cognizant of the conditions that are imposed in the undertaking and carrying out of community development activities with Federal/State financial assistance under Title 1, including those under Title VI relating to the prohibition of discrimination because of race, color, creed or national origin and other assurances as may be forthcoming from the State for the implementation of the Program.
- 3) That the Mayor of the City of Jeannette, on behalf of the Council, is authorized to file an application for financial assistance to carry out the Small Communities Program and act as the authorized representative of the City of Jeannette.
4. That the Mayor, on behalf of the Council, is hereby authorized to provide such assurances and/or certification as may be required by the Housing and Community Development Act of 1974, as amended and any supplemental or revised date which DCED may request in connection with its review of the application and including any revisions necessary to bring the application into conformity with DCED's final grant for the City.
