RESOLUTION NO. 98-5

A RESOLUTION OF THE CITY OF JEANNETTE FOR PLAN REVISION FOR NEW LAND DEVELOPMENT FOR PURPOSES OF APPROVING REVISIONS TO THE OFFICIAL SEWAGE FACILITIES PLAN FOR THE WESTMORELAND INDUSTRIAL DEVELOPMENT CORPORATION JEANNETTE INDUSTRIAL PARK.

THIS RESOLUTION of the Council of the City of Jeannette, County of Westmoreland and Commonwealth of Pennsylvania (hereinafter "the Municipality"),

## WITNESSETH THAT:

WHEREAS: Section 5 of the Act of January 24, 1996, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act", as amended, and the Rules and Regulations of the Pennsylvania Department of Environmental Protection (Department) adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, require the Municipality to adopt an official sewerage facilities plan providing for sewerage services adequate to prevent contamination of waters of the Commonwealth and/or environmental health hazard from sewerage wastes, and to revise said plan whenever it is necessary to determine whether a proposed method of sewerage disposal for a new land development conforms to a comprehensive program of pollution control and water quality management; and

WHEREAS: the Westmoreland County Industrial Development Corporation has proposed the development of a parcel of land identified as the Jeannette Industrial Park, and more particularly described in the attached Sewerage Facilities Planning Module and proposes that such subdivision be served by a sewer extension from existing lines; and

WHEREAS: the City of Jeannette finds that the subdivision described in the attached Sewerage Facilities PLanning Module conforms to applicable sewerage related zoning and other sewerage related Municipal Ordinances and PLans, and to a comprehensive program of pollution control and water quality management.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Jeannette hereby adopts and submits to the Department of Environmental Protection for its approval as a revision to the "Official Sewerage Facilities Plan" of the Municipality of the referenced Sewerage Facility Planning MOdule which is attached hereto.
