RESOLUTION NO. 18-13

**A RESOLUTION OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE COMMONWEALTH FINANCING AUTHORITY (CFA), COMMONWEALTH OF PENNSYLVANIA FOR A FLOOD MITIGATION GRANT TO FUND IMPROVEMENTS AND ADJUSTMENTS FOR THE CITY OF JEANNETTE FLOOD PROTECTION PROJECT.**

WHEREAS, the City of Jeannette (the “City”), a Local Government Unit of Westmoreland County, Pennsylvania, desires to improve the City and support public safety by implementing flood protection;

WHEREAS, City Council desires to submit an application for a Flood Mitigation Grant to obtain financial assistance to offset any additional costs and expenses of the aforementioned Flood Protection Project;

WHEREAS, the City must acquire the additional funding not to over exceed any proposed/existing budget; and

WHEREAS, City Council desires to appoint and designate certain agents for the purposes of executing all forms and documents necessary to obtain relief under this grant, and authorize such agents to do so.

NOW, THEREFORE, WITH THE FOREGOING RECITALS BEING INCORPORATED HEREIN BY REFERENCE THERETO, THE COUNCIL OF THE CITY OF JEANNETTE, WESTMORELAND COUNTY, PENNSYLVANIA, HEREBY RESOLVES AS FOLLOWS:

1. That the City hereby requests a Flood Mitigation Grant of \$492,397.93 from the Commonwealth Financing Authority, to fund the improvements and adjustments related to the City of Jeannette Flood Protection Project; and
2. The city hereby designates Mayor Curtis J. Antoniak and City Clerk/Chief Fiscal Officer, Michelle Langdon, as the officials to execute any and all documents and agreements between the City and the Commonwealth Financing Authority to facilitate and assist in obtaining the requested grant.


