## RESOLUTION NO. 18-15

**A RESOLUTION OF THE CITY OF JEANNETTE AUTHORIZING THE MUNICIPAL AUTHORITY OF WESTMORELAND COUNTY TO ENFORCE §§701, 702, AND 703 OF ORDINANCE 12-03, THE STORMWATER MANAGEMENT ORDINANCE OF THE CITY OF JEANNETTE.**

WHEREAS, the City of Jeannette desires to provide for the adequate enforcement of its stormwater management ordinance; and

WHEREAS, the City of Jeannette desires to benefit from the expertise and resources of the Municipal Authority of Westmoreland County for the enforcement of portions of its stormwater management ordinance.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Jeannette that:

1. The Municipal Authority of Westmoreland County, and its representatives, are hereby authorized to enforce §§701, 702, and 703 of Ordinance 12-03, the Stormwater Management Ordinance of the City of Jeannette, in a manner consistent with the City of Jeannette's interpretation and application of §§701, 702, and 703 of Ordinance 12-03 such that the Municipal Authority of Westmoreland County, and its representatives, shall be authorized to perform inspections, issue notices of violation, and issue citations in connection therewith.

2. The Municipal Authority of Westmoreland County, as a condition of such authorization, shall provide to the City of Jeannette a report, as may be requested by the City but no less than quarterly, of all action taken in enforcing §§701, 702, and 703 of Ordinance 12-03.


3. The Municipal Authority of Westmoreland County, as a condition of such authorization, shall save, indemnify, defend, and hold harmless the City of Jeannette from any claims, causes of action, losses, damages, and liabilities arising from the Municipal Authority of Westmoreland County's enforcement of §§701, 702, and 703 of Ordinance 12-03.

4. Municipal Authority of Westmoreland County, as a condition of such authorization, shall enforce §§701, 702, and 703 of Ordinance 12-03 at no cost or expense to the City of Jeannette.

5. The authorization to enforce §§701, 702, and 703 of Ordinance 12-03 provided in this resolution shall be non-exclusive and that the City of Jeannette shall retain the power and authority to enforce §§701, 702, and 703 of Ordinance 12-03 itself or by and through additional authorized representatives.
