**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JEANNETTE  
APPROVING A PROGRAM REVISION TO THE FISCAL YEAR 2015  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**

**WHEREAS**, the City of Jeannette is a recipient of Community Development Block Grant (CDBG) funds through the Commonwealth of Pennsylvania under the State Act 179; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development (PA DCED) has provided a grant to the City of Jeannette under the FY 2015 CDBG Program to address the housing, community and economic development needs in the City; and

**WHEREAS**, the “Street Improvements – Clay Avenue Curb and Sidewalk” project under the FY 2015 CDBG Program Year is a multi-year project; and

**WHEREAS**, there is a balance of funds remaining in the “Street Improvements – Clay Avenue Curb and Sidewalk” under the FY 2015 CDBG Program Year; and

**WHEREAS**, the scope and beneficiaries of the project remain the same through FY 2015 and FY 2016; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development (PA DCED) has approved the FY 2016 project “Street Improvements – Clay Avenue Curb and Sidewalk” project; and


**WHEREAS**, the City’s Community Development Office has prepared a Program Revision to include the 300 Block along with the 200 Block of Clay Avenue in the FY 2015 CDBG Program Year which will utilize the balance of the Street Improvements Line Item.

**NOW, THEREFORE BE IT RESOLVED**, that the City Council of the City of Jeannette, hereby approves the proposed revision to the FY 2015 CDBG Program Year and authorizes the filing of said revision with the PA Department of Community and Economic Development; and

**BE IT FURTHER RESOLVED** that the Mayor of the City of Jeannette is designated as the Chief Executive Officer authorized to execute all necessary documents on behalf

of the City of Jeannette in regard to the Pennsylvania Community Development Block Grant Program; and furthermore, is authorized and made responsible for performing the overall coordination and administration of the City's FY 2015 Community Development Block Grant Program.
