RESOLUTION NO. 19-13

A RESOLUTION OF THE CITY OF JEANNETTE REQUIRING APPLICANTS FOR STREET CLOSURES TO COMPLETE STREET CLOSURE PERMIT APPLICATIONS; REQUIRING SUCH APPLICATIONS TO BE REVIEWED BY THE POLICE CHIEF AND FIRE CHIEF; REQUIRING APPLICANTS AND USERS TO COMPLY WITH STREET CLOSURE RULES AND REGULATIONS; AND REQUIRING A PERMIT APPLICATION FEE.

WHEREAS, the City of Jeannette receives many street closure requests during each year;

WHEREAS, the City of Jeannette desires to have a formal mechanism for the review of such requests for purposes of promoting public safety;

WHEREAS, the City of Jeannette desires to implement rules and regulations with respect to street closures to protect the safety of persons and property; and

WHEREAS, the City of Jeannette incurs costs in connection with street closure requests.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Jeannette that:

1. The City of Jeannette (the "City") of the County of Westmoreland, Commonwealth of Pennsylvania, hereby requires that any person, organization, company, association, or other entity requesting the closure of any City street or alley shall complete a street closure permit application (on such form or forms as may be prepared by the City) for consideration by the City.

2. All street closure permit applications shall be reviewed by the Police Chief and the Fire Chief of the City, who shall each review such applications for the promotion of public safety and provide a recommendation on such applications to the City Council;

3. As a condition of the approval of any street closure permit application, the respective applicant and all participants in any event for which an application was submitted must confirm with and abide by all Rules and Regulations of the City for the closure and use of streets and alleys, which Rules and Regulations shall be promulgated by the City Council, or a respective Department Head, and as may be amended, and which shall available at City Hall.


4. As a condition of the review of any street closure permit application and the use of any street or alley in relation thereto, the Applicant shall pay a street closure permit application fee in the amount of \$100.00, or such other amount as may be approved by the City Council for street closure permit applications. The City Council shall retain the authority to waive or reduce the street closure permit application fee upon good cause shown, as determined by the City Council.
