

**RESOLUTION OF THE CITY OF JEANNETTE,

APPROVING THE BUDGET MODIFICATION  
OF THE FY 2020 CDBG-CV COMPETITIVE PROGRAM

**WHEREAS**, the City of Jeannette is a recipient of Community Development Block Grant Covid-19 (CDBG-CV) funds through the Commonwealth of Pennsylvania; and

**WHEREAS**, the Pennsylvania Department of Community and Economic Development (PA DCED) has provided a Competitive grant to the City of Jeannette under the FY 2020 CDBG-CV Round 3 Program to address the effects of the Covid-19 Virus by funding activities that will prevent, prepare for, and respond to the coronavirus; and

**WHEREAS**, the PA DCED is making additional CV Round 3 funds available to the City; and

**WHEREAS**, the City is in need of these additional funds to improve its parks and recreational facilities; and

**WHEREAS**, this Budget Modification was presented at a public hearing to give residents the opportunity to comment on the proposed modification; and

**WHEREAS**, the City's staff and Consultant have prepared a Budget Modification which consists of the following:

**FY 2020 CDBG-CV ROUND 3 PROGRAM**

1. Increase the Project Activity Budget for Altman Park from \$454,413.00 to \$710,860.00.
2. Increase the Project Activity Budget for Arlington Park from \$236,392.00 to \$381,000.00.
3. Increase the Project Activity Budget for Agnew Park from \$136,275.00 to \$174,060.00.
4. Increase the Project Activity Budget for Third Street Tot Lot from \$160,117.00 to \$176,500.00.
5. Increase the Project Activity Budget for Centennial Park from \$49,825.00 to \$52,000.00.
6. Increase the Project Activity Budget for West Jeannette Park from \$85,229.00 to \$194,500.00.
7. Delete the Project Activity Budget for the Downtown Amphitheater Project.
8. Decrease the General Administrative Line Item Budget from \$68,545.00 to \$11,080.00.



**BE IT FURTHER RESOLVED** that the Mayor of the City of Jeannette is designated as the Chief Executive Officer authorized to execute all necessary documents on behalf of the City of Jeannette in regard to the FY 2020 CDBG-CV Round 3 Program; and furthermore, is authorized and made responsible for performing the overall coordination and administration of the City's FY 2020 CDBG-CV Round 3 Program.
