**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF JEANNETTE APPROVING AND
AUTHORIZING THE FILING OF A PROGRAM REVISION TO THE FISCAL YEAR 2017 COMMUNITY
DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM**

WHEREAS, the City of Jeannette is a recipient of Community Development Block Grant (CDBG) funds through the Commonwealth of Pennsylvania under the State Act 179; and

WHEREAS, the Pennsylvania Department of Community and Economic Development (PA DCED) has provided a grant to the City of Jeannette under the FY 2017 CDBG Program to address the housing, community and economic development needs in the City; and

WHEREAS, the "Street Improvements Line Item for the 400 Block of Clay Avenue" activity under the FY 2017 CDBG Program Year is completed and there are unused funds; and

WHEREAS, there is a need for additional funds to complete the work under the FY 2018 CDBG Program for the 500 Block of Clay Avenue and also a need for additional funds to balance the budget for the proposed improvements to the 700 Block of Clay Avenue under the FY 2020 CDBG Program; and

WHEREAS, the scope and beneficiaries of the multi-year activity for the Improvements to Clay Avenue remain the same for the FY 2017 Program Year; and

WHEREAS, the City's Community Development Office has prepared a Program Revision to include a reduction in the budget amount for the 400 Block of Clay Avenue, and proposes to add funds for the 500 Block and 700 Block of Clay Avenue;


NOW, THEREFORE BE IT RESOLVED, that the City Council of the City of Jeannette, hereby approves the proposed revision to the FY 2017 CDBG Program Year and authorizes the filing of said revision with the PA Department of Community and Economic Development; and

BE IT FURTHER RESOLVED, that the Mayor of the City of Jeannette is designated as the Chief Executive Officer authorized to execute all necessary documents on behalf of the City of Jeannette in regard to the Pennsylvania Community Development Block Grant Program; and furthermore, is authorized and made responsible for performing the overall coordination and administration of the City's FY 2017 Community Development Block Grant Program.
